NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISE SET FORTH IN THE MOU THE PARTIES HERE TO AGREE AS FOLLOWS:

Clause-I

Preamble:

This Memorandum of Understanding (MOU) is entered into between P. R. Thakur Government College (hereinafter referred to as "the College") and the Thakurnagar Chikanpara Prerana Welfare Society, Chikanpara, Thakurnagar (hereinafter referred to as "the Society") to foster collaboration in the realms of academic initiatives and consumer welfare activities.

Purpose:

The purpose of this MOU is to outline the terms and conditions under which both parties agree to cooperate and collaborate in joint endeavors aimed at enhancing consumer education, awareness, and protection.

Terms and Conditions:

Joint Academic Activities:

The College and the Society agree to collaborate on organizing seminars, workshops, and conferences related to consumer affairs.

Both parties will endeavor to invite expert speakers and practitioners to share insights and knowledge on consumer rights, responsibilities, and best practices.

Either Party shall have the right to unilaterally terminate this MOU upon 90 days prior written notice to the other party.
