

NOW THEREFORE, IN CONSIDERATION OF THE MURUAL PROMISE SET FORTH IN THE MOU THE PARTIES HERE TO AGREE AS FOLLOWS:

Clause-I CO-OPERATION

- Both the parties are united by common interest and objectives, and they shall establish channels of communication and co-operation as far as practicable and to the best of efforts, that will promote and advance-
 - Joint research project and publications, including work by undergraduate and postgraduate students at the partner institutions;
- Faculty and student exchanges (internship) based on reciprocity; ii.
- Reciprocal placement of Students and co-ops, when possible. iii.
- Team taught courses, including online courses and also work in the main spirit of NEP iv. 2020;
- Visits by faculty, professional staff and students; V.
- Exchange of information on Teaching, learning material and other literature relevant to vi. their educational and research programmes;
- Joint organization of short-term continuing education programmes on topics of mutual vii. interest and to invite each other's faculty to participate therein;
- Joint organization of seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein; and
- Any other joint venture for academic enrichment of both the colleges on prior ix. agreement of the Principal/ Officer-in-charge of both the Colleges; within the Institution and its related wings.
- 1.2 Both the Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.3 First Party and Second Party must respect each other's intellectual property and the disputes if any, relating to any aspect of academic cooperation, Principal/ Officer-in-charge of both the College will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
