A) FIRST PARTY is a Government Higher Educational Institution named: P. R. THAKUR GOVERNMENT COLLEGE, P.O.-Thakurnagar, P.S.-Galgghata, District-North 24 Parganas, West Bengal, PIN-743287.

B) First Party and Second Party believe that collaboration and cooperation between themselves will promote more effective use of their resources and provide each of them with enhanced opportunities.

C) The parties intend to cooperate and focus their efforts in cooperation within the area of Higher Education, Research and Development, provide opportunity for global experiences, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions.

D) Both Parties being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

E) Chandpara Block Primary Health Centre, Gnti, Thakurnagar, North 24 Parganas, Pin-743287, West Bengal, the SECOND PARTY, a hospital run by Government of West Bengal and is engaged public health related work such outdoor and indoor treatment of patients, implement different disease control and prevention programme including creating awareness among the society.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISE SET FORTH IN THE MOU THE PARTIES HERE TO AGREE AS FOLLOWS:

Clause-I

Preamble:

P. R. Thakur Government College and Chandpara Block Primary Health Centre recognize the importance of collaboration in promoting healthcare and education in the community. Both parties aim to enhance the quality of medical facilities and resources available to students, staff, and the local community

Purpose:

This Memorandum of Understanding (MOU) establishes a framework for cooperation and collaboration between P. R. Thakur Government College and Chandpara Block Primary Health Centre to facilitate the interchange of medical facilities, resource sharing, and community outreach programs.

Terms and Conditions:

Interchange of Medical Facilities:

P. R. Thakur Government College shall have access to specified medical facilities at Chandpara Block Primary Health Centre for educational and research purposes. Chandpara Block Primary Health Centre shall provide medical facilities to students and staff of P. R. Thakur Government College as needed.

Community Outreach Programs:

Jointly organize free eye checkup camps and distribution of spectacles for the local community. Conduct blood donation camps to promote awareness and contribute to the local blood bank.

Research and Development:

The parties may engage in collaborative research projects focusing on different disease such as vector borne disease, knowledge, attitude practice of society regarding diseases, etc. Research outcomes may be utilized to inform policy maker for formulating better diseases control measures.

Responsibilities:

P. R. Thakur Government College: Coordinate with Chandpara Block Primary Health Centre for the utilization of medical facilities. Organize and promote community outreach programs in collaboration with Chandpara Block Primary Health Centre.

Chandpara Block Primary Health Centre: Provide access to specified medical facilities to P. R. Thakur Government College. Support educational and research activities conducted by P. R. Thakur Government College.

Confidentiality:

Both parties agree to maintain the confidentiality of sensitive information shared during the collaboration and shall not disclose it to third parties without prior consent.

Training and Capacity Building:

The Chandpara Block Primary Health Centre may provide training sessions and capacity-building programs to faculty members and students of the College on topics related to different diseases. Such training initiatives aim to empower stakeholders with the knowledge and skills necessary to control and prevention of different diseases.

Resource Sharing:

Both parties agree to share resources, including infrastructure like rooms and seminar rooms, for educational and training activities.

Chandpara Rural Hospital will provide necessary support for academic programs and research conducted by P. R. Thakur Government College.

Duration:

This MOU shall come into effect upon signature by both parties and shall remain valid for a period of 5 years unless terminated earlier by mutual consent or due to unforeseen circumstances.

Amendment and Termination:

This MOU unless terminated by mutual written agreement will continue for 5 years after the effective date specified in the opening paragraph and can be renewed through mutual consent. Either Party shall have the right to unilaterally terminate this MOU upon 90 days prior written notice to the other party.
