

Following the allegations ^{of misbehaviour} brought against Rani Mondal, a 2nd Year student of English Honours, by students of the college, a ~~new~~ meeting of the Disciplinary Committee had been called, asking all the involved parties to be present, in the Principal's Chamber at 12 noon on 11/09/2018.

The complaint stated that Rani Mondal, a junior student had allegedly misbehaved with a senior student, Shubhrojit Biswas, ^{studying in the} ~~A~~ third year ~~in~~ in the Dept. of ~~English~~. After speaking to all the parties concerned, it was ~~resolved~~ clear that it was not a deliberate act of misbehaviour on Rani's part, though she had indeed been rude to Shubhrojit, and was a case of misunderstanding.

The Disciplinary Committee resolved that Rani should apologise to Shubhrojit in public and with Rani's public apology the matter rested there.

Ripán Sikder, a third-year student of the Bengali Department, was accused of ~~beating~~ hitting a ~~the~~ ^{1st} Semester student of the 1st Semester of the Department of Sociology, namely Kunal Biswas. ~~He~~ The former was asked to appear before the Disciplinary Committee on 11/09/2018, in the Principal's Chamber, at 1:00 pm.

~~The~~ The members of the Disciplinary Committee had already been made aware of the incident from eye witnesses and the CCTV footage. Upon questioning Ripan, he accepted the charges made against him, stating that he did what he felt would uphold the moral reputation of the college as he felt that Kunal Biswas ~~was~~ had been indulging in behaviour inappropriate to the discipline and reputation of the college. He ~~ad~~ also admitted to having hit Kunal with a rod. He was accompanied by some other students but none of them were actually involved in the said altercation between Ripan Sikder and Kunal Biswas. Ripan has submitted a written statement acknowledging all ^{these} allegations, ~~and to~~

Hence, the Disciplinary Committee resolved that Ripan Sikder, should be penalised for his actions and not be allowed to enter the college premises ~~unless~~ for a period of two months, unless his departmental teachers, ^{or the college authority,} ~~can~~ give him special permission to do so. This is the suggestion of the Disciplinary Committee, but the final decision rests upon the Officer-in-Charge of the college, as the charges are ^{of a} ~~very~~ grievous nature.

Proceedings of the meeting of the Disciplinary Committee
held on 11.09.2018 in the Principal's Chamber
regarding the incident that had taken place on 29.08.2018.

As notified earlier, the concerned student, Sri Ripan Sikder, Third Year Bengali Hons, appeared before the committee. He was asked to describe the incident that had taken place on 29.08.2018. As he described it, the members questioned him to clear the inconsistencies in his statements. Finally, he was asked to submit a written statement about the incident. He had with him such a statement already written and submitted it. But it was observed that a number of facts had been concealed in his writing, and so he was asked to write a fresh statement and submit it, and he did so. Both the statements are in the possession of the committee.

In his statement, the student agreed that on 29.08.2018, on the second floor of the college building, he had deliberately hit another student with a steel tube, which he had collected from the ground floor. According to him, he was acting as a moral police from the students' side.

In the CCTV footage of the incident which had already been seen by some of the members earlier, the student was seen hitting the other student with the said steel tube. But at the time of meeting it came to the knowledge of the committee that the footage had already been deleted automatically, even though it had been requested to save the footage. The only proof of the guilt remains the student's statement.

It was revealed from the conversation that according to the result of B.A. Part-II Examination 2018, Sri Ripan Sikder is now a Third year (General) student, unless a review of the result goes in favour of him. In this anticipation the student was attending third year honours classes regularly, and urged the committee repeatedly to let him attend those classes.

Recommendation:

In view of the knowledge about this student's previous activities, the following actions are being recommended:


1. He may not be allowed to enter the college and attend the classes on a regular basis.
2. He may be permitted to enter the college only to meet the teachers who will guide him for preparation of Part-III (Honours) examination, at most once a week, and should not remain in the college after such meetings. His attendance will be calculated separately. This is subject to the approval of his departmental teachers.
3. If the departmental teachers find his progress not upto the mark, his permission for entering the college will be withdrawn.
4. If the result of the review of Part-II Examination remains the same (i.e., QG) he will have no honours subject. In that case he will have to appear as a non-collegiate student and the permission, as mentioned in item 2, will be withdrawn.
5. For any other reason, extremely necessary, he may enter the college with prior permission from the Principal.
