## Minutes of the meeting dated 06/09/2019

In the meeting ~~with the~~ of the Disciplinary Committee, in collaboration with the Grievance Redressal Cell, with the students (16 students from different departments of the college), it came to light that the behaviour of Dulal Mondal (3<sup>rd</sup> Semester, Dept. of Political Science) and Mousumi Roy (3<sup>rd</sup> Semester, Dept. of Bengali) seemed improper and ~~unsuit~~ unsuitable within the premises of an educational institution. ~~The~~

Most of the students were of the opinion that despite several warnings to check their behaviour, Dulal and Mousumi paid no heed to them and continued with what these students deem as 'shameless' behaviour.

These sixteen students are sincere and serious in their academic aspects and as such have given us no reason to doubt their words. Dulal and Mousumi had not been asked to appear before the Disciplinary Committee today, as they will have to be dealt with separately on another day, for which the date and time has been fixed as 12<sup>th</sup> September 2019 at 1.45pm.

Minutes of the meeting dated with Prof. Koushik Shaw,  
dated 06/09/2019 :-

In Prof. Shaw's meeting with the Disciplinary Committee and the Grievance Redressal Cell, it was apparent that the attitude and behaviour of Dulal Mondal (a 3<sup>rd</sup> Semester student of Prof. Shaw's Department) had humiliated him. Prof. Koushik Shaw had felt insulted at Dulal's response when he had questioned Dulal's behaviour and the latter's response had aggravated him.

Prof. Shaw did not mention anything, though, about any compromising behaviour on the part of Dulal and Mousumi.

Prof. Koushik Shaw's statement seems to be contradictory to those made by the students who had submitted the complaint against Dulal and Mousumi.

This fact was corroborated by the O-I-C, Prof. Suparna Sarkar, who agreed with the students' version.

Yet, she too, gave it in writing that she would not do anything in future that would cause others to lodge a complaint against her.

With these two assurances in writing, the Disciplinary Committee and the Grievance Redressal Cell let the two students off with warnings of dire consequences if such incidents were repeated and reported again.

Proceedings of the Meeting of the Disciplinary Committee, held on 06/02/2020

Following the complaint of Priti Mondal, a Fourth Semester student of the Dept of English, against Arghya Biswas, a Second Semester student of the Dept. Of Political Science, of misbehaving with her within the college premises, an incident which was witnessed by several students of the departments of English, Philosophy and Computer Science, the involved students, including Priti, Arghya and the witnesses for both sides was called by the Disciplinary Committee on the 6<sup>th</sup> of February 2020.

Unfortunately although the complainant and her friends who had witnessed the event were present at the meeting, none of the accused were there.

Hence, it was decided by the Disciplinary Committee that whatever decision would be taken, would be "in absentia", that is without giving the absent students a chance to offer their version of the events.
